## Fábrica de água de ciclo completo com processo automatizado máximo

A água potável é produzida com um sistema de filtragem de osmose reversa (RO), um sistema de filtragem que usa uma membrana especial. Também conhecida como Membrana, que é feita de fibras de celulose sintética com uma resolução de 0,0001 micron, que é menor que um fio de cabelo. Com essa propriedade, ela faz com que a solução de contaminantes como metais pesados, fertilizantes químicos, pesticidas, chumbo e vários patógenos maiores não penetrem nessa membrana de filtro. Somente os fios puros podem penetrar.

Os contaminantes presos no meio filtrante são imediatamente removidos do sistema para evitar o acúmulo dentro da unidade, separando-os da água pura filtrada. Esse método faz com que a água RO seja filtrada.
