As empresas sediadas em Lisboa são especializadas na fabricação de uma ampla gama de próteses externas e órteses para braços e pernas. Essas empresas também oferecem uma variedade de produtos ortopédicos para fins clínicos, hospitalares, esportivos e de recuperação, além de equipamentos de fisioterapia preventiva e geriátrica. Elas utilizam técnicas tradicionais de moldagem, bem como tecnologia 3D em seus processos de produção.
