    - 2,10% Chumbo (Pb)
    - 2,75% Zinco (Zn)
    - 31,84% Enxofre (S)

    - 0,4 – 1,25 g/t de ouro (Au)
    - 30 – 225 g/t de prata (Ag)
  - Rico em matérias-primas essenciais classificadas pela UE, incluindo cobalto (Co), índio (In), antimônio (Sb), bismuto (Bi) e arsênio (As).
- Rejeitos existentes com valor adicional:
  - 575.000 toneladas de rejeitos valiosos contendo metais preciosos e não ferrosos avaliados entre € 50 e € 100 milhões.
- Potencial de profundidade inexplorado:
  - Não foi realizada nenhuma exploração moderna, perfuração de núcleo de diamante ou pesquisas geológicas avançadas.
  - Alta probabilidade de reservas de minério mais profundas e inexploradas.
