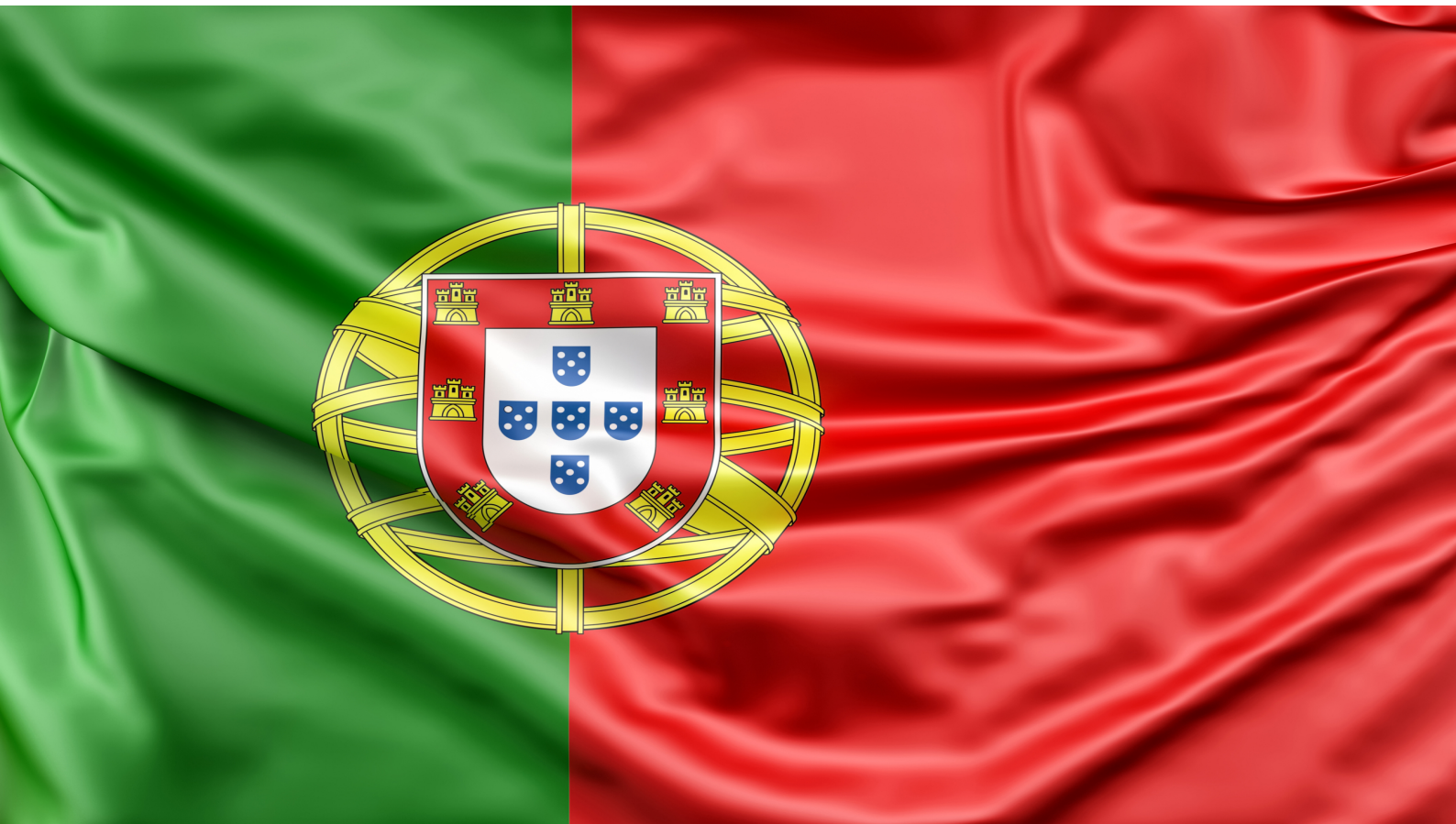

Financeiramente, o clube conta com o apoio de um grupo diversificado de patrocinadores e parceiros, e tem mais de 900 afiliados ativos que contribuem por meio de taxas mensais de associação.
