## Usina de energia solar fotovoltaica de 1,85 MW (Piazza Armerina) RTB

O Projeto de Conexão Solar Piazza Armerina é uma iniciativa significativa de energia renovável focada na integração de uma nova usina de energia solar de 1.850 kW à rede elétrica nacional na Sicília, Itália. Esse projeto representa um esforço estratégico para expandir a infraestrutura de energia limpa e apoiar as metas de transição energética do país.

### Principais dados do projeto

- Título do projeto: Projeto de conexão solar da Piazza Armerina
- Localização do projeto: Strada Provinciale, 169, Piazza Armerina, Enna, Sicília, Itália
- Tipo de projeto: Conexão de usina solar fotovoltaica (PV)
- Potência de saída solicitada: 1.850 kW
- Potência nominal: 1.850 kW
- Conexão com a rede: Média tensão (MT)
- Solução técnica: A conexão será realizada com a construção de uma nova cabine de distribuição e sua conexão com a rede de média tensão existente. O trabalho inclui a instalação de 1.450 metros de novos cabos aéreos e 25 metros de cabos subterrâneos.
- Custo estimado da conexão: €122.383,62 (IVA incluído)
- Cronograma estimado: O tempo estimado para que o operador da rede conclua sua parte do trabalho é de 97 dias úteis, sujeito aos termos e condições padrão do contrato de conexão.

**Importância do projeto** Esse projeto contribui para o crescimento da geração de energia renovável na Itália. Ao conectar uma usina solar substancial à rede, ela ajuda a diversificar as fontes de energia e aumenta a capacidade geral de produção de energia sustentável na região. O projeto também destaca os complexos requisitos logísticos e técnicos envolvidos na integração de sistemas de energia renovável em grande escala às redes de distribuição de energia existentes.

**Parceiros** O projeto é uma colaboração entre o proprietário da usina (o produtor) e a operadora da rede nacional, a e-distribuzione S.p.A., que é responsável por executar os trabalhos de conexão à rede e garantir a conformidade com todos os padrões regulatórios.
