Atualmente, ela está ativa na Cidade de Buenos Aires e possui uma licença regulatória válida. Há vários anos, a CNV (Comissão Nacional de Valores Mobiliários) não concede novas licenças para operar como agente. Isso decorre de uma política de cotas limitadas, com o objetivo de manter um número controlado de participantes do mercado. O objetivo é garantir a ordem regulatória e evitar a saturação excessiva das operadoras, o que poderia dificultar a supervisão ou aumentar os riscos sistêmicos.

Nesse contexto, a única maneira de entrar no mercado como um agente autorizado é adquirindo uma licença existente. Isso pode ser feito por meio da aquisição da empresa que já detém a licença, o que implica assumir o controle de seu patrimônio.
