A propriedade está totalmente equipada com instalações equestres de primeira linha, incluindo um andador para até 8 cavalos, um ringue de salto, arenas externas profissionais e um picadeiro interno adequado para competições internacionais. Este haras histórico foi amplamente reformado e totalmente atualizado, combinando seu caráter tradicional com as mais recentes tecnologias modernas.

Localização e cenário

Situada em uma das regiões economicamente mais dinâmicas da Europa, a propriedade se beneficia da proximidade imediata de aeroportos internacionais, universidades importantes e grandes centros metropolitanos. A propriedade oferece um raro equilíbrio entre privacidade e acessibilidade – cercada por paisagens naturais intocadas e, ao mesmo tempo, perfeitamente conectada à vida urbana.
