- Pronto para entrar em operação imediatamente, com racks de servidor pré-instalados, conectividade de rede, PDUs, sistemas de ventilação e cortinas de resfriamento a água.
- Reduz significativamente os prazos de implantação e as necessidades de gastos de capital para os novos operadores.

Infraestrutura elétrica robusta

- Com 15 transformadores com capacidade nominal de 2.500 kVA cada, garantindo uma distribuição de energia confiável e eficiente por todo o local.

- Toda a instalação fica dentro de um perímetro totalmente cercado, o que aumenta a segurança e a resiliência operacional.
