

# Mineração de ouro "Ridley Lake"





## Mineração de ouro "Ridley Lake"

O Projeto Ridley Lake Gold consiste em 196 reivindicações contíguas não patenteadas de mineração de célula única e de fronteira nas quais a Richmond detém 100% de participação. O Projeto está localizado centralmente no Swayze Greenstone Belt, no centro-norte de Ontário, em Rollo e Raney Townships, Porcupine Mining Division ou, mais especificamente, 40 km a sudoeste da cidade de Foleyet e 120 km a oeste-sudoeste da cidade de Timmins.

Descobertas de ouro significativas recentes dentro do SGB incluem o depósito de Cote Lake (adquirido pela Iamgold em abril de 2012 por US\$ 585 milhões), e a descoberta de ouro da Probe Mines Borden Lake (recentemente adquirida pela Goldcorp por US\$ 526 milhões), um depósito de ouro de vários milhões de onças localizado aproximadamente 23 milhas a oeste.

- Os primeiros trabalhos de prospecção da Propriedade remontam à prospecção de 1932. Dois veios de quartzo (o Cyril Knight e o Aguara Showings) com orientação leste-oeste foram descobertos na área central da propriedade. Esses veios foram expostos em superfície para comprimentos de gretas de até 245 m, com larguras variando entre 1 e 3 m. Os ensaios desses veios foram altamente variáveis, com teores variando de valores de traços até 23 g/t de ouro (0,7 onças por tonelada).
- O projeto pode ser acessado durante todo o ano por uma rede de estradas madeireiras e florestais e é sustentado por parte de uma grande sequência de vulcânicos e sedimentos pré-cambrianos chamados de complexo vulcânico Swayze ou cinturão metavulcânico-metasedimentar Swayze-Deloro.
- A mineralização de ouro descoberta através da perfuração de diamantes até o momento no projeto está associada a uma variedade de características geológicas que incluem desenvolvimento de zona de cisalhamento, sistemas de estoque de carbonato de quartzo e contatos entre fluxos félsicos e máficos.
