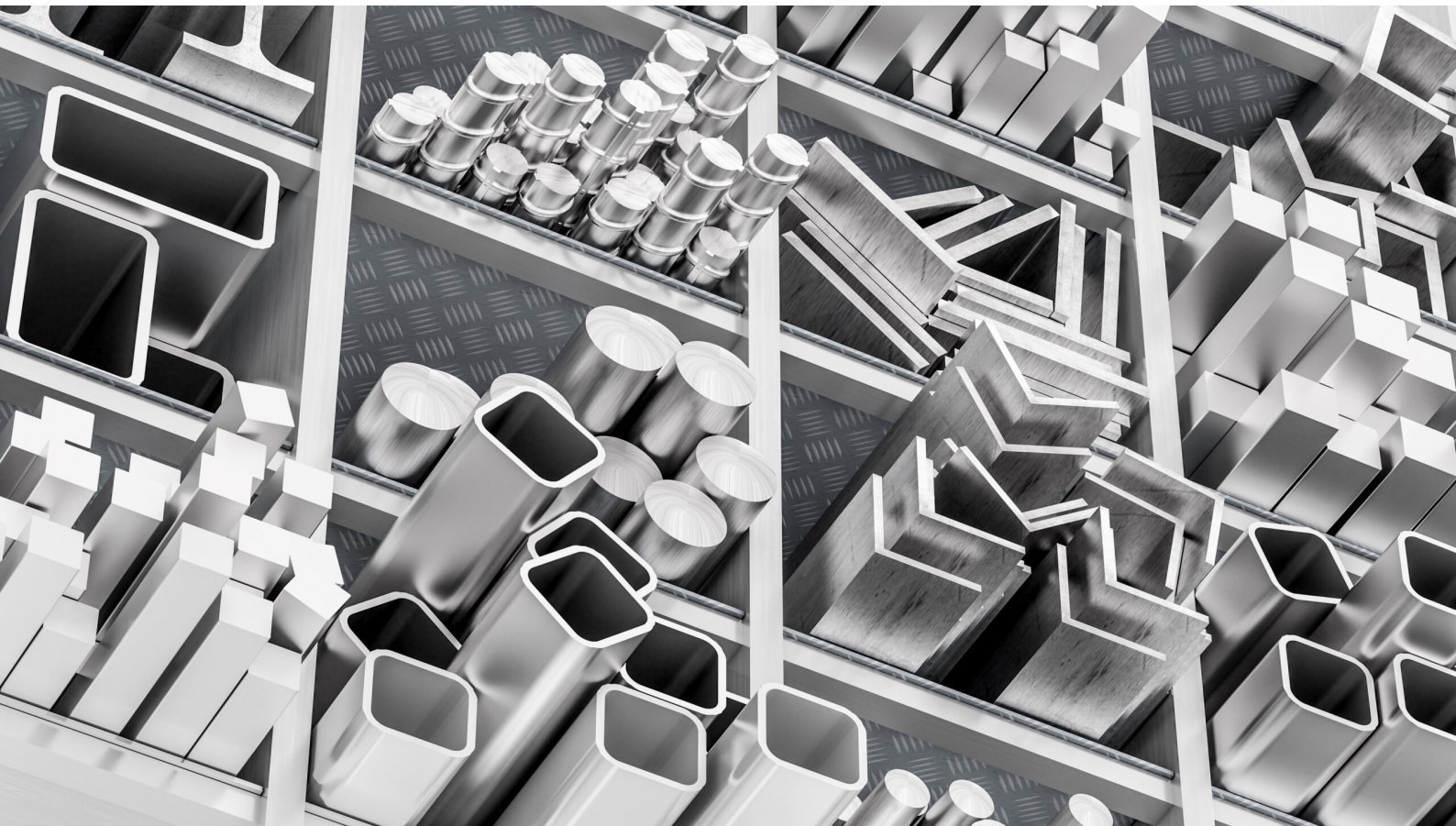


# Fabricante de perfil de alumínio





## Fabricante de perfil de alumínio

Fundada em 1991, esta empresa de fabricação de metal para venda é uma das principais produtoras de perfis de alumínio na Turquia. A Metal Company desembarcou em uma área total de mais de 40.000m<sup>2</sup> perto de Istambul. A Companhia possui 3 linhas de extrusão em escalas de 2750, 1850 e 1540 toneladas. A extrusora 2750 da empresa é uma das maiores prensas automáticas do setor, podendo produzir perfis temperados de 310 mm de largura e 13,4 metros de comprimento.

Com mais de 20.000 toneladas de capacidade de produção por ano, a empresa se dedica à produção de perfis padrão, perfis sigma, perfis de móveis, perfis de led/refrigeração, perfis de energia solar.

A empresa tem uma forte estratégia de mitigação de risco diversificando sua base de clientes, vende por meio de empresas industriais e empresas de construção em toda a Turquia (mais de 20 países e mais de 300 clientes no exterior)

### Oportunidades

O consumo de alumínio primário cresceu globalmente 21,3% entre 2013 e 2017, refletindo o dinamismo do mercado downstream e a maior penetração do metal. O crescimento da demanda global de alumínio deverá ser de 3,8% até 2021.

Em 2019, o tamanho do mercado global de alumínio foi de 123,2 bilhões de dólares. O grupo de produtos Barras, Chapas e Rolos respondeu por 26,7% do mercado global de alumínio.
