Fundada em Izmir, Turquia, em 1971, com base na fabricação e no design de moldes de injeção de plástico.

Por um longo período, a empresa tem trabalhado com o projeto e a fabricação de moldes para muitas empresas importantes do país. Durante esse período, surgiu a necessidade de ter uma máquina de injeção em casa para os disparos de teste dos moldes fabricados, o que fez com que a empresa se tornasse também uma processadora de injeção ao mesmo tempo.

Em 1990, projetou a primeira caixa de ferramentas com a marca registrada. A empresa iniciou o período em que se tornou um fabricante de equipamentos de armazenamento de plástico. O design e a marca foram os primeiros para o mercado doméstico naquela época.

Com esse início, que causou uma reação muito atraente, a empresa aumentou rapidamente a variedade de produtos e começou a exportar em 1993.

Em 2004, a empresa mudou-se para a fábrica atual e continua com o objetivo de oferecer produtos e serviços de qualidade em todo o mundo.

A empresa tem a visão de estar equipada com as fontes necessárias para melhorar a qualidade e o serviço.

Desde 2002, o sistema é certificado pela AQA (American Quality Accessories) sob a norma ISO9001:2000.

A fábrica está localizada em uma área total de 10.000 m², dos quais 8.000 m² são a área fechada de fabricação, equipada com máquinas de processamento e injeção de plástico de alta qualidade totalmente automáticas.
