## Mina de ouro operacional em exploração

O Quirguistão tem muitas das maiores minas de ouro da Ásia Central.

Localizada nas encostas ao norte da cordilheira Kirghiz, nas partes superiores, componentes direitos do córrego Karabulak, na parte central dos campos de minério de Bulakashinsky.

As rochas vulcânicas fazem parte da estrutura geológica do local. rochas representadas por andesitos e andesitos-basaltos, seus tufos e clastolavas. As rochas intrusivas são representadas por gabro-sonquinitos, sienito-dioritos e granodioritos, que são fases separadas de um único complexo intrusivo. Uma característica das formações desse complexo é sua ocorrência em forma de lençol, suavemente inclinada, com ângulos de mergulho de 10 o a 50 o , nas rochas vulcânicas-sedimentares circundantes.

Com essas estruturas e associadas à formação de zonas mineralizadas e corpos de minério do depósito.

A mineralização de ouro e cobre identificada, bem como as zonas de beresitização e silicificação no local de Severny, estão confinadas diretamente às intrusões de granodiorito ou, mais frequentemente, aos seus contatos intrusivos com rochas vulcanogênicas e intrusivas hospedeiras.

A largura da zona de beresitização aqui atinge as primeiras dezenas de metros. comprimento rastreado de 400 m. Entre os beresitas, o veio mais intenso silicificação, com disseminação de sulfetos de cobre, chumbo, ferro e molibdênio.

### Pontos-chave

O depósito de ouro é, na verdade, um grande campo que consiste em vários depósitos de ouro e um depósito de cobre. O vendedor alega ter um alto teor de ouro (porcentagem de teor de ouro por 1 tonelada). No entanto, o campo não está bem desenvolvido. Todos os dados são coletados por engenheiros soviéticos e parece que nada foi feito desde aquele período.

As reservas qualificadas como P1 e P2, que são de acordo com os padrões canadenses ou australianos, são iguais a: Resultados de exploração, alvos de exploração, potencial de exploração ou até mesmo algumas podem ser consideradas inferidas. Esses são os níveis mais baixos de exploração
