## Time de Futebol da Espanha "Tercera División RFEF"

Tercera División RFEF, também conhecida apenas como Tercera RFEF, é a quinta divisão do sistema de ligas de futebol espanhol. Fica abaixo da Primera División (também conhecida como La Liga), da Segunda División, e das divisões semi-profissionais Primera División RFEF e Segunda División RFEF. Foi fundada em 1929 como terceira divisão, e reduzida para a quarta e quinta divisão em 1977 e 2021, respectivamente.

Uma grande oportunidade para adquirir um Time de Futebol Espanhol na "Tercera División RFEF" (Terceira Liga Espanhola). Atualmente o órgão regular de futebol na Espanha é a Federação Royal de Futebol Espanhol (RFEF), que está encarregada dos times nacionais e suas ligas, com a mais alta sendo La Liga. A RFEF foi fundada em 1909 e é membra tanto da FIFA como da UEFA.

A Tercera División RFEF possui 18 grupos regionais (como a antiga quarta divisão Tercera División), correspondendo às comunidades autônomas da Espanha (devido ao tamanho, a Andalusia foi dividida em dois grupos, Leste e Oeste; Ceuta está localizada no oeste de Andalusia, enquanto Melilla está localizada no leste), na qual cada grupo é administrado por uma federação de futebol regional. No final da temporada, os primeiros quatro times em cada grupo qualificam para amistosos promocionais que decidem quais times são promovidos para a Segunda División RFEF.

Pelo menos os últimos três times finalizando na base de cada grupo podem ser relegados para as Divisiones Regionales de Fútbol. Porém, o número de times relegados pode variar. Os campeões dos dezoito grupos também se qualificam para a próxima temporada da Copa del Rey. Contudo, times reservas não são elegíveis. Junto com times da Segunda División RFEF, os times restantes da divisão competem na Copa Federación.
